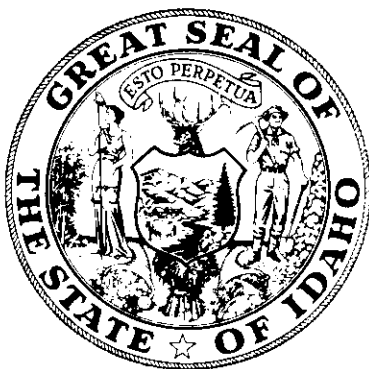

ARTICLE OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
DOUBLE D FEED & SEED, INC.

KNOW ALL MEN BY THESE PRESENTS, that a special meeting held on the 11th day of December, 1979, pursuant to written Waiver of Notice and Consent of all the stockholders of the corporation, the following Resolution was unanimously adopted by vote of approval of all of the stockholders of the corporation as follows, to-wit:

BE IT RESOLVED, that the Articles of Incorporation of Double D Feed & Seed, Inc. be and the same are hereby amended and modified as follows, to-wit:

ARTICLE V.

The amount of capital stock of this corporation shall be 250,000 share of common stock of the par value of \$1.00 per share, for a total capitalization of \$250,000.00. Each share of common stock shall have the same rights, privileges and voting power and the same shall be fully paid and non-assessable.

The remaining and preceding Articles of the said Articles of Incorporation of Double D Feed & Seed, Inc. shall remain the same and shall not be amended or modified in any way except as the same appear to this date.
