NATIONAL MUSTANG ASSOCIATION

a Non-profit Corporation

### KNOW ALL MEN BY THESE PRESENTS:

We, the undersigned, whose residence appears herein opposite our respective names, having associated ourselves together for the purpose of forming a non-profit corporation under and by virtue of the laws of the State of Utah, do hereby adopt the following Articles of Incorporation.

#### ARTICLE I

The name of this corporation shall be the NATIONAL MUSTANG ASSOCIATION, with perpetual existence unless dissolved by operation of law, and its principal place of business within the State of Utah shall be in Newcastle, Iron County, State of Utah.

#### ARTICLE II

The names and residences of the incorporators are as follows:

#### ARTICLE III

The general nature and function and the objects of this non-profit corporation shall be to receive gifts and grants of money and property of every kind; to solicit and enlist membership; to publicize, promote, preserve and perpetuate the wild Mustang horse within the boundaries of the State of Utah, the western states and in all places within the United States of America; said organization shall be strictly non-profit and without pecuniary remuneration to any member, person or party, save and except actual expenses duly authorized and expended and full time employees,

HARLAN BURNS ATTORNEY AT LAW 95 NORTH MAIN CEDAR CITY, UTAN authorized and hired for administrative purposes; said organization shall be strictly for the sole purpose of doing all things necessary and proper for the accomplishment of such benevolent, recreational and humane purposes as hereinabove set forth.

#### ARTICLE IV

This non-profit corporation shall have an unlimited number of members who shall consist of all persons, either corporate or private, who have contributed and/or donated the sum of Five Dollars (\$5.00) or more to this non-profit corporate organization; that all members shall meet and convene at a duly and regularly called annual meeting on the first Monday of March of each and every year, and notice of such meeting shall be published at least one time in the IRON COUNTY RECORD, or other publication having general circulation within Cedar City and Iron County, Utah.

#### ARTICLE V

The affairs of this non-profit corporation shall be conducted by a Board of Trustees which shall be at least five in number and not more than fifteen in number. Said Board of Trustees shall be elected annually on the first Monday of March of each and every year at said regular meeting. Until their successors shall be elected and qualified, the following persons shall constitute the Board of Trustees and hold offices set opposite their names:

The Board of Trustees shall have the power to adopt, amend, and rescind the By-laws of this non-profit corporate entity.

#### ARTICLE VI

The private property of the incorporators, members, Board of Trustees, and Officers of this non-profit corporation shall be forever exempt from its debts and obligations.

#### ARTICLE VII

The initial and principal office of this non-profit corporation shall be located in Newcastle, Utah, which said office may be changed at any time by the Board of Trustees without amending said Articles of Incorporation; the address of the entitled registered office is C. Tom Holland, P. O. Box 26, Newcastle, Utah, a bona fide resident of the State of Utah for the period of more than three years immediately proceeding the date hereof, and who is hereby designated and appointed agent of this non-profit corporation upon whom all notices and processes, including service of Summons, may be served and the service upon such agent shall be lawful personal service upon the corporation. This appointment may be revoked at any time by the filing of the appointment of another agent as provided by law.
