# ARTICLES OF INCORPORATION OF PAFFILE PRODUCE EXPRESS, INC.

#### KNOW ALL MEN BY THESE PRESENTS:

THAT WE, DONALD P. PAFFILE, CLAUDE R. WAITE and DELORES I.

PAFFILE, each being a natural person of full age and a citizen of
the United States of America, have this day voluntarily associated
ourselves together for the purpose of forming a corporation under
and pursuant to the laws of the State of Idaho, and we do hereby
certify as follows:

## FIRST

That the corporate name of this corporation shall be:

PAFFILE PRODUCE EXPRESS, INC.

#### SECOND

That the purposes and objects for which said corporation is formed are as follows:

- (a) To engage in the business of purchasing, selling, exchanging and transporting of agricultural produce and commodities in the State of Idaho and elsewhere.
- (b) To construct, acquire, operate, lease, mortgage, sell, or otherwise dispose of facilities for the storage and/or preservation of agricultural produce and commodities purchased by the corporation for resale and also such stores and warehouses for the reception and storage of such agricultural products as shall be necessary to engage in the above referred to business of buying, selling, exchange and transport of agricultural produce and commodities.
- (c) To engage in the rental, loan and lease of trucks, tractors, trailers, and all other types of motor vehicles, and, in connection therewith, to purchase and sell motor vehicles and equipment, vehicle parts, accessories, and to perform repairs and improvements in connection with the leasing, loaning or rental of such vehicles and to acquire, hold, deal on any and all licenses, permits and franchises necessary or useful in connection with the business.

- (d) To purchase, lease or otherwise acquire in whole or in part, the business, assets, goodwill, rights, franchises and property of every kind and to take over the whole or any part of such assets and/or liabilities of any firm, person, association or corporation engaged in or having authority to engage in the same general type of business authorized to be conducted by this corporation, or owning property, either real or personal, necessary or suitable for its purposes, and to pay for the same in cash or in the stocks and bonds of this corporation, or otherwise; and to hold or in any manner dispose of the whole or any part of the business or property so acquired, and to exercise all the powers necessary or incidental to the carrying on of such business.
- (e) To acquire, buy, own, hold, sell, exchange, let or lease such personal property and real property as may be necessary or incidental to the carrying on of the business of the corporation.
- (f) To purchase or otherwise acquire, own, hold, mortgage, pledge, sell, assign, transfer or otherwise dispose of shares of capital stock of this corporation.
- (g) To enter into any contract, pension trust, cooperative agreement or profit sharing plan with its officers and/or employees which the corporation may deem advantageous or expedient or to otherwise reward or pay such persons for their services as the directors of the corporation may deem fit.
- (h) To borrow money for the purposes of this corporation and to issue bonds, notes or debentures or other evidences of the indebtedness therefor and to secure the same by mortgage or pledge of personal property, including the income of the corporation or by mortgage of real or personal property, executed in trust or otherwise.
- (i) To exercise generally the powers customarily exercised by business corporations and particularly the powers provided by the laws of the State of Idaho referring especially to Section 30-114 Idaho Code.
- (j) To carry on any other business, or to do anything in connection with the objects and purposes above mentioned that may be necessary or proper to accomplish successfully or promote the said objects and purposes.

The foregoing clauses, by reason of the specific enumera-

tion of these powers, shall not be held to restrict the power of

the corporation to do any of the things within the purview of its general purposes.

#### THIRD

That this corporation shall have perpetual existence.

## FOURTH

That the location and post office address of the registered office of this corporation in the State of Idaho and its principal place of business shall be at 15th and Dutro North, Lewiston, Nez Perce County, State of Idaho.

## FIFTH

That the capital stock of this corporation shall consist of FIFTY THOUSAND (50,000) shares of common stock having a par value of ONE DOLLAR (\$1.00) per share and an aggregate par value of FIFTY THOUSAND DOLLARS (\$50,000.00); each of such shares shall be non-assessable when fully paid for.

The capital stock of this corporation shall not be divided into classes, but shall consist of only one class, that being common stock; and each share of stock shall be entitled to one vote in all matters wherein the share holders of this corporation shall be entitled to vote, and each share shall in all respects be equal to every other share.
