

SECRETARY OF STATE

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is FREEDOM INCORPORATED.

SECOND: The period of its duration is perpetual.

THIRD: The purposes for which the corporation is organized are the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 50,000 shares of common capital stock with a par value of One Dollar (\$1.00) per share.

FIFTH: The address of the initial registered office of the corporation is ~~Star Route~~, ^{H.C. 70, Box 2275} Midvale, Idaho 83645, and the name of its initial registered agent at such address is Frank D. Cada.

SIXTH: The management of the corporation shall be by the shareholders and there shall be no directors, as provided by Idaho Code, §30-1-35.
