## ARTICLES OF INCORPORATION

OF .

CRYSTAL POOLS AND GUNITE CO., INC.

## KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are full aged citizens of the State of Idaho and of the United States of America and are bona fide residents of the State of Idaho, have this day voluntarily associated ourselves, and do by these Articles of Incorporation unite ourselves, for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

I.

That the name of the corporation shall be: CRYSTAL POOLS AND GUNITE CO., INC.

II.

That the purposes for which said corporation is formed are as follows:

To act as a general contractor for the construction, repairing, and remodeling of buildings and works of all kinds, and for the improvement of real estate, and the doing of any and all other business and contracting incidental thereto, or connected therewith, and the doing and performing of any and all acts or things necessary, proper, or convenient for or incidental to the furtherance or the carrying out of the powers or purposes herein mentioned.

In general, to carry on anyother business in connection with the foregoing, and to have and exercise all the powers conferred by the laws of Idaho upon corporations formed

under General Corporation Law of the State of Idaho, and to do any or all of the things hereinbefore set forth to the same extent as natural persons might or could do.

III.

The period of existence of this corporation shall be perpetual.

IV.

The registered office and place at which the principal business of this corporation shall be conducted is the City of Coeur d'Alene, County of Kootenai, State of Idaho.

The total authorized stock of this corporation shall be Five Thousand Dollars (\$5,000.00) divided into five thousand shares of the parvalue of One Dollar (\$1.00) per share.
