The undersigned, acting as incorporators under the Idaho Business Corporation Act, adopt the following Articles of Incorporation.

I. NAME OF CORPORATION

The name of the corporation is Thomsen Construction, Incorporated.

II. DURATION

The period of its duration is perpetual.

III. PURPOSE OF CORPORATION

The purpose or purposes for which the corporation is organized are:

To engage in the business of construction contracting for profit together with the transaction of all lawful businesses for which corporations may be incorporated under the Idaho Business Corporation Act.

IV. STOCK

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of common stock at the par value of \$1.00 per share.

V. CORPORATION REGULATIONS

The internal affairs of Thomsen Construction, Incorporated shall be regulated by such By-Laws as may be provided for the corporation and in addition shall be regulated in accordance with the provisions of the Idaho Business Corporation Act, Section 30-1-23(a).
