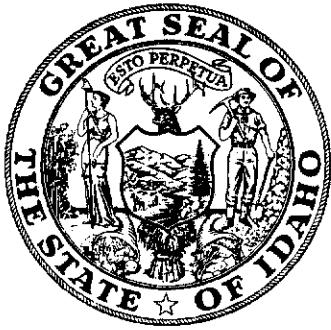

In compliance with the requirements of Idaho Code, Section 30-1001, (Nonprofit Corporations), the undersigned, all of whom are citizens of the United States, and all of whom are of full age, have this day voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

ARTICLE I

The name of the Corporation shall be "4-H CENTER, INC., hereinafter called "Corporation".

ARTICLE II

The location and principal office of the Corporation is 3939 Brookside Lane, Boise, Idaho, 83703. The registered agent of the Corporation is Steven C. Purvis whose address is 3939 Brookside Lane, Boise, Idaho, 83703.

ARTICLE IV

PURPOSES AND POWERS OF ASSOCIATION

This Corporation does not contemplate pecuniary gain or profit to the members thereof, and the specific purpose for which it is formed is to provide a 4-H Center. In addition, the Corporation shall have and be allowed to exercise any and all powers, rights and privileges which a Corporation organized under the Non-profit Corporation Laws of the State of Idaho may now or hereafter have or exercise.

ARTICLE V

Upon winding up and dissolution after adequate provision has been made for the payment of the debts of the Corporation, all assets of the Corporation shall be placed in or revert to a nonprofit fund, foundation, or corporation which has

established its exempt status under Section 501(c)(3) of the Internal Revenue Code.

ARTICLE VI

Every person who desires to serve in a 4-H or Grange capacity and who are voted to be admitted pursuant to the Corporate By-Laws shall be a member of the Corporation.

ARTICLE VII

VOTING RIGHTS

Each Corporation member shall have and be entitled to one vote.

ARTICLE VIII

BOARD OF DIRECTORS

The affairs of the Corporation shall be managed by a board of seven (7) directors, who shall be members of the Corporation. The number of directors may be changed by amendment of the By-Laws of the Corporation.
