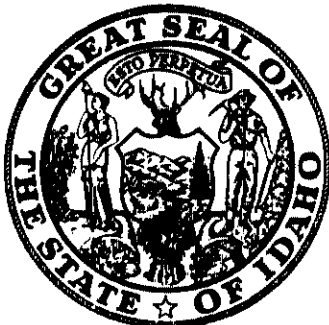
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

B P QUALITY ENTERPRISES, INC.

The undersigned, acting as the incorporators of a corporation under the provisions of the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is B P QUALITY ENTERPRISES, INC.

SECOND: The period of its existence is perpetual.

THIRD: The purposes for which the corporation is organized shall be the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

FOURTH: The corporation shall have authority to issue 100,000 shares of capital stock having a one dollar (\$1.00) par value. All of such shares shall be voting common stock having full rights of participation in the profits, losses and assets of the corporation.
