#### ARTICLES OF INCORPORATION

### TRISTATE THEATRES.

KROWALL MORE BY Those Presents: That we, EDWIN B. RIVERS, MARY E. RIVERS and W. M. LINEBAUGH, of Lewiston, New Perce County, Idaho, being all citizens of the United States, and residents of the State of Idaho, have this day voluntarily associated curselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do make, subscribe and certify the following articles of incorporation, to-wit:

( Name )

The name of this corporation is "TRISTATE THEATRES".

( Term of Existence )

The term for which this corporation shall exist shall be fifty (50) years from end after its incorporation.

## (Principal Place of Business)

The principal office and place of business of this corporation shall be in the City of Lewiston, County of Nez Perce, State of Idaho, but meetings of the stockholders may be held at any other place within the State of Idaho upon such notice as shall be prescribed by the By-Laws, and meetings of the directors may be held within or without the State of Idaho, when meetings without the state are authorized by the By-Laws or by resolution of the Board of Directors.

## IV.

The objects, purposes and powers of this corporation shall be as follows, to-mit:

To acquire by lease, purchase or any means and use, own and operate theatres, moving picture houses and other places of amusement, and to engage in and carry on a theatre, moving picture and amusement business;

To acquire, buy, sell, hold, lesse, manage, operate, own and control buildings, structures, lands and all interests therein;

To purchase or otherwise acquire, own, sell and dispose of stocks and bonds of other corporations and to exercise all the rights and privileges which a corporate owner may lawfully exercise;

To lend money with or without security, and to take security in such forms and on such properties as the company may deem proper; to borrow money and to evidence such indebtedness by notes, bonds or other securities and to secure the same by a mortgage, pledge or in any other manner;

To acquire, ewn and use patents and copyrights, and to act as licensee, factor or agent, and to make any and all contracts which may be deemed messessary or expedient for the conduct, management and development of the company's business and property.

In general, to exercise all powers which are, or may be, granted by the laws of the State of Idaho to corporations of like character; to have and exercise all powers incidental or necessary to the purposes and powers herein expressed, and to engage in and carry on any other business in connection with the foregoing, whether manufacturing or otherwise, not contrary to law and the charter of this corporation, it being expressly provided that the foregoing enumeration of specific powers shall not be held to limit or restrict in any manner the general powers of this corporation; and to carry on its business in any other states when authorized by the laws of such states.

To sell any property or interest of the company whenever it is deemed expedient, and to sell the entire property, business and good will of the corporation upon the conditions authorized by law.

# V. (Capital Stock)

The empital stock of this corporation is Ten Thousand Dollars (\$10,000,00), divided into One Hundred (100) shares of the per value of One Hundred Dollars (\$100.00) each.

VI. ( Number of Directors )

The number of directors of this corporation shall be three(5), and the names and places of residences of the three incorporators who will carry on the business of the ecoporation until the first meeting of the stockholders are as follows:
