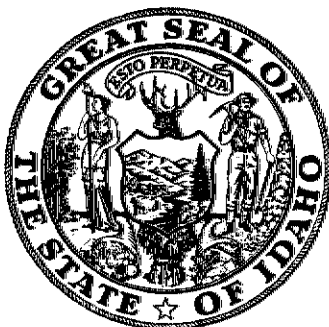

ARTICLES OF INCORPORATION

FOR

G & A DEVELOPMENT, INC.

ARTICLE I

NAME: The name of the corporation shall be G & A DEVELOPMENT, INC.

ARTICLE II

DURATION: The corporation shall remain in existence until dissolved by action of the Board of Directors.
