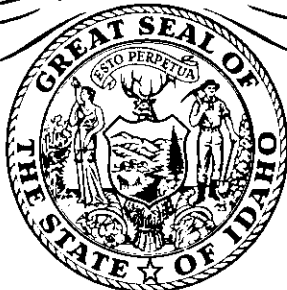

ARTICLES OF INCORPORATION

OF

SUPER SPORTS, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, ROYCE ASHER, RICHARD SNYDER, NICK PURDY AND ROBERT GARDNER, all residents of the State of Idaho, each and all of whom are citizens of the United States and natural persons of full age, have this day voluntarily associated ourselves together for the purpose of forming a corporation for profit under the laws of the State of Idaho, and we do hereby certify and state:

1. That the name of said corporation is and shall be Super Sports, Inc.

2. That subject to dissolution in the matter provided by law, the life of this corporation shall be perpetual.

3. That the purposes for which said corporation is formed are as follows:

A. The sales, service, rental, and lease of recreational type vehicles and all components and parts which are usually and customarily incident thereto and part thereof, and the instruction of persons in the operation and maintenance of the aforementioned items. In addition, the acquisition of land and any improvements thereon or appurtenances thereto, or any interest therein and the erection, construction, maintenance and repair of any buildings, structures, or other improvements thereon, with the right to incumber, sell and convey any and all interest therein, such as may be necessary or customary to the sales, service, rental, lease, and instruction of persons in the operation and maintenance of the equipment, as aforesaid.

B. To own, lease, and/or operate all equipment necessary to conduct excursions upon any public or private lands, providing such land is open to travel by recreational type vehicles and/or that prior permission has been granted to travel on public or private lands, within the State of Idaho, other states, District of Columbia, territories or colonies of the United States, and foreign countries.

C. To receive, acquire, hold, purchase, dispose of, convey, mortgage and/or lease, real and personal property; to dispose of, sell, lease, assign, transfer, mortgage, and/or convey any rights, privileges, duties, franchises, licenses, real or personal property of the corporation, other than its franchise of being a corporation, and to acquire, purchase, guarantee, hold, mortgage, own, vote, sell, pledge and/or otherwise dispose of and deal in shares, bonds, securities, and debentures and other evidences of indebtedness of other corporations, domestic, public or foreign.

D. To conduct business in this state, other states, the District of Columbia, territories or colonies of the United States and foreign countries, and to have one or more offices and places of business out of this state, and to acquire, receive, hold, purchase, lease, mortgage, dispose of and/or convey real and personal property situated out of this state.

E. To enter into, make, perform, and carry out contracts of every kind and for any lawful purpose, without limit as to amount, with any person, firm, association, trust, partnership, corporation, municipality, state or national government, or any subdivision, district or department thereof.

F. To appoint such officers, employees and agents as the business of the corporation may require and to allow them compensation.

G. To sue and be sued, appear, complain and defend in any court of law or equity, or before any board, commission, or tribunal.

H. To do any and all such other acts, things, business or businesses in any manner connected with or necessary, incidental, convenient or auxillary to any of the objects hereinabove enumerated, or calculated, directly or indirectly, to promote the interests of the corporation in carrying on its purposes, or for the purpose of attaining or furthering any of its business.

I. The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in no wise limited or restricted, by reference to, or inference from, the terms of any other clause, which shall be regarded as independent purposes and powers; and no recitation, expression, or declaration of specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

4. That the location and post office address of the registered offices of this corporation shall be P. O. Box 501, Sun Valley, Blaine County, State of Idaho.

5. That the amount of the authorized stock of said corporation shall be \$50,000.00 divided into 50,000 shares of common stock at the par value of \$1.00 each. Said stock shall be nonassessable. The names and post office addresses of each of the incorporators and the number of shares subscribed by each is as follows:

6. In case a stockholder desires to sell his share or shares of stock, he must first offer them for sale to the remaining stockholders. Being the intention hereof to give them a preference to the purchase of the same and any attempted sale in violation of this provision is null and void. The stockholder desiring to sell his stock shall file notice in writing of his intention with the secretary of the incorporation stating the terms of sale and unless the terms are accepted by any or all of the other stockholders within thirty days thereof, they shall be deemed to have waived their privilege of purchasing and he be at liberty to sell to anyone else upon the same terms as were offered to the other stockholders.

7. That the business of the corporation shall be managed by a board of directors composed of at least three shareholders. The number of directors is four. The names and the residences of the persons who are appointed to act until the first meeting of their successors are as follows:

8. The assets of the corporation can be sold or merged with another corporation by a majority vote of the shareholders.
