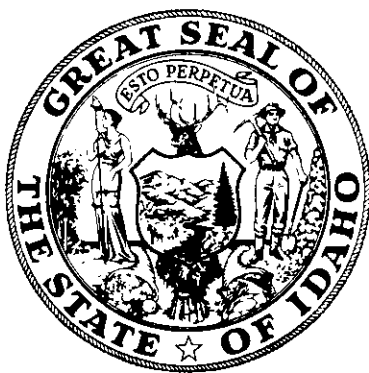

ARTICLES OF INCORPORATION
OF
LAJOMAC GROUP, INC.

The undersigned acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation is LAJOMAC GROUP, INC.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares. The shares shall be without par value. The shares shall not be divided into classes. There shall be no restrictions on the issuance of stock rights or stock options.

Each outstanding share shall be entitled to one vote and to the extent permitted by law, there shall be no right to vote cumulatively at the election for directors.

ARTICLE V

Shareholders shall not have preemptive rights to acquire any of the 100,000 authorized but unissued shares of the corporation.

ARTICLE VI

Provisions for the regulation of internal affairs of the corporation are as more fully set forth in the Bylaws.

ARTICLE VII

The address of the initial registered office is 877 N. Liberty Street, Suite #201, Boise, Idaho 83704 and the name of its initial registered agent at such address is John Lawrence Corwin.

ARTICE VIII

The number of directors constituting the initial board of directors of the corporation is two (2) persons and the names and addresses of the persons who are to serve as initial directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:

ARTICLE IX

The stock of the corporation shall be deemed to be Section 1244 stock such that the tax benefits made available pursuant to Section 1244 of the Internal Revenue Code as same may be amended shall be applicable.
