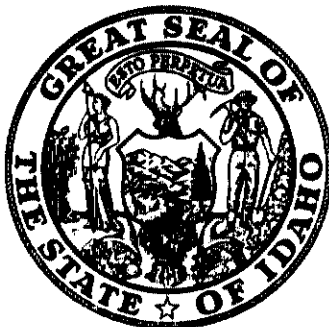
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is KAMIAH AUTO PARTS, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is one thousand (1,000) with a par value of \$1.00.

FIFTH: Provisions denying preemptive rights are: none.

SIXTH: Provisions for the regulation of the internal affairs of the corporation shall be provided for in the by-laws of the corporation.

SEVENTH: The address of the initial registered office of the corporation is 404 Oak Street, PO BOX 36, Nezperce, Id. 83543 and the name of its initial registered agent at such address is Daniel M. Johnson, Attorney at Law.




