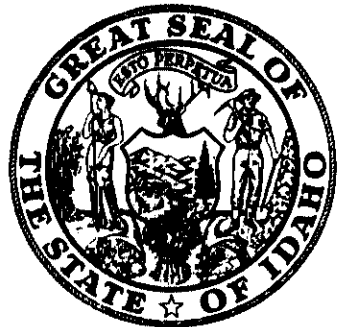
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

The undersigned, acting as incorporators of a Corporation under the Idaho Non-Profit Corporation Act, adopts the following Articles of Incorporation for such Corporation:

I

NAME

The name of the Corporation is LEMHI RIFLE AND PISTOL CLUB, INC.

II

DURATION

The period of duration is perpetual.

III

PURPOSES

The purposes and objects for which the Corporation is organized are:

1. To promote social welfare and public safety; law and order, to educate and train citizens of good repute in the safe and efficient handling of small arms and promote efficiency in the use of small arms on the part of members of law enforcement agencies, of the National Defense groups, and of citizens dedicated to the shooting sports. Generally to encourage the lawful ownership and use of small arms by citizens of good repute.

2. To provide a common gathering place for those persons who enjoy guns and shooting. To sponsor Local, State, Regional and National Shooting Tournaments.

3. To cooperate with the National Rifle Association of America and other associations in carrying out their activities.

The Corporation shall hold, buy, sell and lease such assets as are necessary to carry out the aforementioned purposes and shall do all things necessary to carry out all aforesaid purposes.

IV

STOCK

The Corporation will not issue stock but will issue membership certificates as set forth under the rules and regulations of the directors.

(1) Pecuniary profit is not the object, or any object of this corporation. No part of the assets or earnings of the corporation shall inure to the benefit of, or be distributable to its members, directors, officers, or other private persons, except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes, and that the Corporation may carry on its business on a basis which may earn operating and administrating expenses, discharging the obligations of said corporation contracted within its powers hereunder, and provide funds with which to carry on future services of the type described above.

(2) No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting, to

influence legislation, and the corporation shall not participate in, or intervene in any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on

(a) by a corporation exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of subsequent laws, or

(b) by a corporation, contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code of 1954 or the corresponding provisions of subsequent laws.

(3) Upon dissolution of the corporation, the Board of Directors shall, after paying or making provisions for the payment of the liabilities of the corporation, dispose of all the assets of the corporation exclusively for the purposes of the corporation in such manner, or to such organization or organizations organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c)(3) of the Internal Revenue Code of 1954 or the corresponding provisions of subsequent laws, as the Board of Directors shall determine.

V

LOCATION AND REGISTERED AGENT

The address of the initial registered agent of the corporation is 101 Washington Ave., Salmon, Idaho 83467, and the initial registered agent at such address is CODY HASLETT.
