Volco, Inc., as Surviving Corporation

Whereas Volco, Inc., hereinafter called Volco or the surviving corporation, is an Idaho corporation with its principal place of business at 515 West Main Street, Jerome, Idaho; and

Whereas the aggregate number of shares that Volco is authorized to issue is 100,000 shares of a par value of \$10.00 each, of which 90,909 shares are outstanding; and

Whereas Volco Builders Supply, Inc., hereinafter called Volco Builders Supply, is an Idaho corporation with its principal place of business at Jerome, Idaho; and

Whereas the aggregate number of shares that Volco Builders Supply is authorized to issue is 10,000 common shares at a par value of \$10.00 each, of which 6,734 shares are outstanding and are owned legally and beneficially by Volco; and

Whereas Volco Builders Supply of Twin Falls, Inc., hereinafter called Volco of Twin Falls, is an Idaho corporation with its principal place of business at Twin Falls, Idaho; and

Whereas the aggregate number of shares that Volco of Twin Falls is authorized to issue is 10,000 common shares at a par value of \$10.00 each, of which 5,476 shares are outstanding and are owned legally and beneficially by Volco; and

Whereas Volco Builders Supply of Burley, Inc., hereinafter called Volco of Burley, is an Idaho corporation with its principal place of business at Burley, Idaho; and

Whereas the aggregate number of shares that Volco of Burley is authorized to issue is 25,000 common shares at a par value of \$10.00 each, of

which 4,490 shares are outstanding and are owned legally and beneficially by Volco; and

Whereas it is desirable for the benefit of all parties and their shareholders that the properties, businesses, assets, and liabilities of all parties be combined into one surviving corporation which shall be Volco, Inc.;

Now, therefore, in consideration of the premises and the mutual agreements herein contained, the parties hereto in accordance with the applicable provisions of the laws of the State of Idaho do hereby agree as follows:

- 1. Merger. Volco Builders Supply, Volco of Twin Falls, and Volco of Burley shall be merged with and into Volco, and Volco does hereby merge Volco Builders Supply, Volco of Twin Falls, and Volco of Burley with and into itself. On and after the effective date of this merger:

 - (b) Volco Builders Supply shall cease to exist as a separate corporation, and all of its property shall become the property of Volco, Inc., the surviving corporation, and the officers and directors of Volco Builders Supply shall forthwith make such deeds, conveyances, and transfers as shall be sufficient to accomplish the vesting of legal title to all of the presently owned property of Volco Builders Supply in Volco, Inc.
 - (c) Volco of Twin Falls shall cease to exist as a separate corporation, and all of its property shall become the property of Volco, Inc., the surviving corporation, and the officers and directors of Volco of Twin Falls shall forthwith make such deeds, conveyances,

and transfers as shall be sufficient to accomplish the vesting of legal title to all of the presently owned property of Volco of Twin Falls in Volco, Inc.

- (d) Volco of Burley shall cease to exist as a separate corporation, and all of its property shall become the property of Volco, Inc., the surviving corporation, and the officers and directors of Volco of Burley shall forthwith make such deeds, conveyances, and transfers as shall be sufficient to accomplish the vesting of legal title to all of the presently owned property of Volco of Burley in Volco, Inc.
- 2. Articles of incorporation; by-laws. The Articles of Incorporation and By-Laws of Volco shall continue as the Articles of Incorporation and By-Laws of the surviving corporation.
- 3. <u>Directors</u>. The directors of Volco shall be the directors of the surviving corporation until their successors are duly elected and qualified under the By-Laws of the surviving corporation.
- 4. Shares of survivor. Each common share of Volco outstanding on the effective date of the merger shall thereupon, without further action, become one common share of the surviving corporation, without the issuance or exchange of new shares or new share certificates.
- 5. Cancellation of shares of Volco Builders Supply, Volco of
 Twin Falls, and Volco of Burley. All authorized and outstanding common
