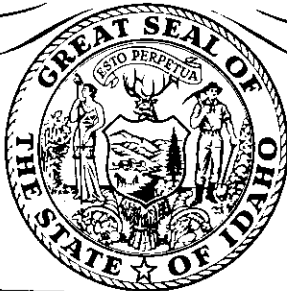

5 KNOW ALL MEN BY THESE PRESENTS, that we, the un-
6 derigned, at least two-thirds of whom are citizens of the United
7 States, and of full legal age, have this day voluntarily associa-
8 ted ourselves together for the purpose of forming a corporation
9 under the laws of the State of Idaho, and we hereby certify in
10 writing:

11 I.

12 The name of said Corporation shall be STEINER
13 ELECTRONICS, INC..

14 II.

15 The objects and purposes for which this Corpora-
16 tion is formed are to conduct and operate an electronic, television,
17 radio, stereophonic and hi-fidelity manufacturing, construction,
18 sales, service and repair business in all its branches, at whole-
19 sale and retail, and sales, service and repair of any and all elec-
20 trical, mechanical or other instruments, devices, products or ma-
21 terials. And in connection with any of the foregoing, to acquire,
22 lease, own, handle, improve, encumber, sell contracts, sell or
23 lease or otherwise dispose of any and all products, or real and
24 personal property. To own, vote, sell, pledge, or otherwise dis-
25 pose of and deal in the shares of this Corporation or any other
26 corporation; to do all acts permitted by law herein, and in I.
27 C. § 1114 and all the laws amendatory thereof and supplemental
28 thereto. In fact, to do all and all of the things that may be
29 necessary or pertinent or expedient in connection with, or to ac-
30 complish any of the foregoing objects.

III.

The registered office and place where the principal business of said Corporation is to be transacted is at the office of the company in Lewiston, Nez Perce Count, , Idaho.

IV.

The duration of this Corporation and the term of its existence is perpetual.

V.

The number of directors of said Corporation shall be three, each of whom must be a shareholder. The number of directors may be increased by the shareholders at any regular meeting or at any special meeting of which notice of such purpose is given. A director shall hold office for the term for which he was named or elected, or until his successor is elected and qualified.

VI.

The total authorized capital stock of said Corporation is 100 shares at the par value of \$100.00 per share; each share entitles its holder to one vote without preference. The stock shall be common stock and shall be non-assessable.

VII.

The Board of Directors of this Corporation shall be and they hereby are authorized to determine the value of any property or consideration, other than money, which is offered, tendered or paid for corporate stock. The power to repeal and amend the By-Laws, and adopt new By-Laws, is hereby conferred upon the Board of Directors.

VIII.

The amount of capital stock of the Corporation which has actually been subscribed is three shares, which shares have been subscribed to by the following named persons, who are also the incorporators, and the names and addresses of said incorporators,
