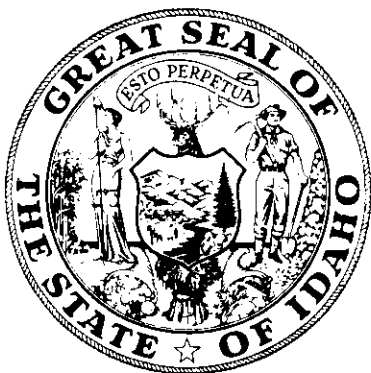

VII.

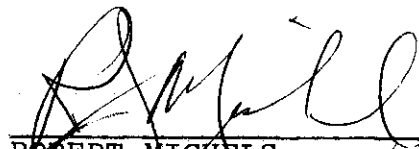

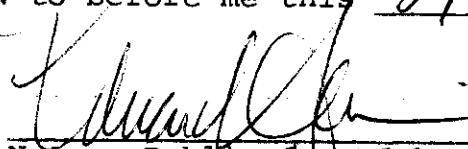
