

Know all men by these presents:
That we the undersigned have
this day voluntarily associated
ourselves together for the purpose
of forming a corporation under
the laws of the State of Idaho.

And we hereby certify: -
First, That the name of said corporation
is the Mullins Canal and Reservoir
Company, which may have a common
seal and alter same at pleasure.

Second, That the objects and purposes
for which this corporation is formed
are: -

(a) The construction and digging of
canals and ditches for the purpose
of conveying water for sale, rental,
and distribution for agricultural,
manufacturing, mining and
other useful purposes.

(b) The building and construction
of reservoirs for accumulating and storing
water to be used in agricultural, mining,
manufacturing, and other useful in-
dustries.

(c) The acquisition by purchase
or otherwise, of ditches, canals,
reservoirs and water rights and
privileges to be used for conveying,
storing and furnishing for sale,
rental and distribution, water to be used

1 in the various industries; also to
2 acquire by purchase, lands for agric-
3 cultural or Mining purposes, and
4 operate the same or dispose of it
5 at pleasure.

6 Third, That the stockholders may make
7 such by laws as may be deemed
8 expedient for the regulation and
9 management of its affairs, not inconsistent
10 with this instrument.

11 Fourth, That the place where the
12 principal business of said corporation
13 is to be transacted shall be the town of
14 Shoshone Logan County, Idaho, but
15 may be changed to any other place by
16 a vote of the majority of stockholders.

17 Fifth, That the highest amount of
18 indebtedness which may be incurred
19 shall not exceed five thousand (\$5000)
20 dollars unless approved by a vote of three
21 fourths of the stockholders.

22 Sixth, That the term for which it is to
23 exist is fifty years from and after its
24 incorporation.

25 Seventh, That the number of its direc-
26 tors shall be five, and that the names
27 and residences of those who are
28 appointed for the first year are:—

Eighth, That the amount of Capital Stock
of this corporation shall be Five Hundred
and Fifty Thousand Dollars (\$250,000⁰⁰)
divided into five thousand (5000) shares
of the par value of Fifty Dollars each,
but to commence business when
Three Thousand (3000) shares shall have
been subscribed and four thousand
dollars have been paid into the Treasury
or expended in work.

Ninth, That the amount of said
Capital Stock which has been actually
subscribed is One Hundred and Fifty
Thousand (\$150,000⁰⁰) Dollars and the
following are the names of the persons by
whom the same has been subscribed:
