Amendment of Articles of Incorportion of Spirit Lake Volunteer Ambulance, Inc. as follows:

- 1. Amend Article II. by adding; This organization is organized exclusively for charitable and educational purposes within the meaning of section 501 (C) (3) of the Internal Revenue Code.
- 2. Add Article XI. to read as follows: "Upon the dissolution of this organization, assets shall be distributed for one of more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code ( or any corresponding section of any future tax code), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assests not so disposed of shall be disposed by the Court of Common Pleas of the County in which the principal office of the organization or organizations, as said Court shall decide."

On September 2, 1992 at 7:00pm, a special meeting of the general membership of the Spirit Lake Volunteer Ambulance, Inc. and its Board of Directors, was held. The above Amendments were reviewed.
