ARTICLES OF AMENDMENT

OF

THE FIRST CHRISTIAN CHURCH OF PAYETTE, IDAHO, INC.

NOTICE IS HEREBY GIVEN That a special meeting of the Board of The First Christian Church of Payette, Idaho, on the 2nd day of March, 2014, at the office of said church, in Payette, Idaho, shall conduct this meeting to amend Article II, Article III, Article VIII, and add Article XI to the original Articles of Incorporation of 1899. The amendments to these articles shall read as;

Article II

No part of the church organization earnings shall benefit or be distributed to its members, trustees, or other private persons, except that the church organization can pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof. The church organization shall not carry on any other purposes not permitted to be carried on (a) by an organization exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future tax code, or (b) be an organization, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code or corresponding section of any future federal tax code. The principal place of business transactions of this corporation shall be in the town of Payette, in the County of Payette and the State of Idaho.

Article III

The church organization is organized exclusively for religious, educational, and charitable purposes according to the teachings of The New Testament of our Lord and Savior, Jesus Christ, including for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code.

Article VIII

Upon the dissolution of the church organization, assets shall be distributed to one or more religious organizations with 501(c)(3) tax exempt status in compliance with 501(c)(3) of the Internal Revenue Code. In the event a chosen religious organization does not meet 501(c)(3) status, the church will seek another organization that does meet 501(c)(3) status. Any such assets not disposed of by the church, shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organizations, as said court shall determine, which is organized and operated exclusively for such purposes.

Article XI

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the church organization shall not participate in, or intervene in (including publication or distribution statements) and political campaign on behalf of any candidate for public office.

ON THE 2ND DAY OF MARCH 2014 THE CHURCH ORGANIZATION ASSETS SHALL BE DISPOSED OF

As said above these amended articles shall be accepted on the 2nd day of March, 2014.
