## ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, the

being a person of full age and being a citizen of the United States, in order to form a corporation for the purposes hereinafter stated, pursuant to the Business Corporation Act of Idaho, do hereby certify that:

FIRST: The name of the corporation is GRANITE TRANSPORTATION SERVICES, INC.

SECOND: The purposes for which said corporation is formed are: Transportation and brokerage of freight, and any other lawful purpose.

THIRD: The corporation is to have perpetual existence.

FOURTH: The corporation will do all banking transactions from Westone Bank, Meridian Branch, Meridian, Idaho.
