#### ARTICLES OF INCORPORATION

The name of the corporation is  ${\tt GOODING}$  COUNTY MEMORIAL HOSPITAL FOUNDATION, INC.

This corporation is organized pursuant to Chapter 3 of Title 30, Idaho Code, as a non-profit corporation.

The period of its duration is perpetual.

Its purpose is to transact all business not forbidden by the law, provided however its primary function is to procure and extend financial aid of the operation, management and expansion of facilities of the Gooding County Memorial Hospital, Gooding, Gooding County, Idaho.

The corporation shall have members, and the conditions of membership in said corporation shall be set forth in its By-Laws and shall be evidenced by Certificates of Membership.

The affairs of the corporation shall be managed by a Board of Directors. The number of directors constituting the initial Board of Directors of the corporation is six and the names and addresses of the persons who are to serve as initial directors are listed on page 2.
