The company is formed for the purpose of Manufacturing Flour, Meal and Feed, and for Distilling Ardent Spirits from Grain, and to perform all kinds of business belonging to Grist, Milling and Distilling and for the purpose of carrying on such business, may acquire by purchase, hire or otherwise such real estate as may be necessary.

The amount of Capital Stock of the company shall be Ten Thousand Dollars.

The Stock shall consist of Two Hundred shares of Fifty Dollars each

The time of the existence of the said company shall be Twenty Five Years. There shall be three Trustees and David Heron, George Goodrich and William H. Drake

shall be the Trustees to manage  
the concerns of the company for  
the first Three Months, and there-  
after shall be elected by the Stock  
holders at such times, and in  
the manner as the By Laws  
prescribe

The principal place of  
business of the company shall  
be located in the City of Boise  
Ada County Idaho Territory
