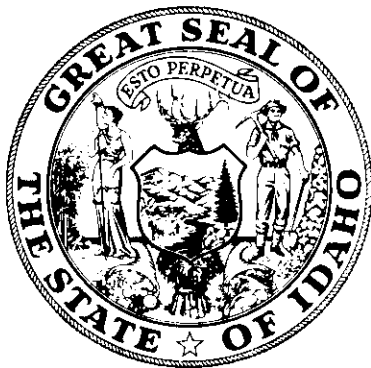

ARTICLES OF AMENDMENT

COMMUNITY SERVICE ALTERNATIVES, INC.

On June 21, 1985, the members of the Corporation voted to adopt the following amendments. There was a quorum present, and the proposed amendments were approved by majority vote.

Section 3: The general purpose of the Corporation is to act as a placement agency or as a liaison between court referred volunteers, probationers and parolees who have been ordered by the Court or Prosecutor's Office or the Department of Probation and Parole, to perform community services and the users of said services, which users shall include, but not necessarily be limited to, disadvantaged individuals, including senior citizens, low income citizens, handicapped persons and disabled persons, and to find work sites within the community of Ada County for such users with tax exempt and non-profit agencies, both public and private, or associations or groups; and to engage in any activity concerning or relating to any lawful placement services for which non-profit corporations may be incorporated under the Idaho Non-Profit Corporation Act of the State of Idaho. The Corporation does not contemplate, and its activities do not result in pecuniary gain or profit incidental or otherwise to its members.

This Corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code.

Section 11: Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501 (c)(3) of the Internal Revenue Code. No part of the net earnings of the Corporation shall inure to the benefit of any individual, and no member of the Board of Directors, officer or employee of the Corporation shall receive

any pecuniary benefits of any kind except reasonable compensation for services in effecting the Corporate purpose. However, the Corporation shall have all of the rights, duties and obligations of any other corporation that may be formed under the laws of the State of Idaho, providing such activities are not engaged in with the intent of making pecuniary profits.

Any provision of law to the contrary notwithstanding, the Corporation may not merge or consolidate with any Corporation which is not an exempt corporation, as defined in Section 501 (c)(3) of the Internal Revenue Code.

Upon winding up and dissolution of the Corporation, after paying or adequately providing for the debts and obligations of the organization, the remaining assets shall be distributed to a non-profit fund, foundation, or corporation which has established its tax exempt status under Section 501 (c)(3) of the Internal Revenue Code.


