OF THE

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, a majority of whom are citizens and residents of the State of California, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of California.

AND WE HEREBY CERTIFY:

FIRST:- That the name of said corporation shall be the "ENNIS-BROWN COMPANY";

SECOND:- That the purposes for which it is formed are:

To own, conduct, manage, control, operate, and carry on, in all its branches, a wholesale and retail fruit and produce and commission business in the State of California, and elsewhere in the United States and Foreign Countries;

To buy and sell, by wholesale and retail, own, hold, pledge, mortgage, hypothecate, give, grant, lease, rent, and otherwise acquire, hold, deal in, and dispose of all kinds of fruit, produce, groceries, goods, wares, merchandise, wooden ware, iron ware, patented articles, implements, machines, and all other kinds of personal property;

To buy, own, acquire, hold, build, erect, construct, use, manage, operate, lease, sell, convey, rent, mortgage, pledge, hypothecate, and otherwise deal in real estate, buildings, structures, and personal property of every kind;

To buy, acquire, own, hold, sell, pledge, hypothecate, and otherwise deal in, hold, and dispose of, any and all kinds of public and private stock, bonds, notes, mortgages, pledges, securities, judgments, choses in action, patents, inventions, and all other kinds of personal property, including its own stock;




