## Article 2: The purpose for which the corporation is organized is:

### Purpose:

The corporation is organized exclusively for charitable, benevolent, educational, and religious purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code (or corresponding provision of any future U.S. IRS Code) in order to establish Events, Teachings, Retreats, Worship Services & Conferences to further help others grow in their faith, family, and quality of life.

The corporation will solicit, receive, and maintain funds to use in furtherance of the above purpose in accordance with its mission and vision set out below.

Among other things, this includes the fact that no part of the funds received or earnings of this corporation shall inure to the benefit of any private member or individual except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in the furtherance of its purpose, mission, & vision.

### Mission:

With every event, teaching, retreat, worship service, or conference, it is our mission to further the Gospel of Jesus Christ. We wish to encourage people to live out their faith, and put it into action. That they might have a more abundant, full life.

#### Vision:

We envision men, women, and children pursuing a deeper more meaningful relationship with Jesus Christ through every event we are a part of. We envision lives being changed for the better, as they realize their identity in Christ.

#### Additional Information:

One of the primary functions of this ministry, is to put on Christian based events. We will at times hire a speaker, rent out a facility, and charge attendee's to come. However, the costs are not covered by the registration fees of the attendants. So additional donations to cover things like insurance, facility and equipment rentals, supplies, handouts, musical guests, and giveaway's, among other things, will be necessary. Marketing and promotional expenses will be incurred, and part of the use of funds donated.



### Scriptural Foundation:

Proverbs 27:17 – As iron sharpens iron, so one person sharpens another.

1 Thessalonians 5:11 – Therefore encourage one another and build each other up, just as in fact you are doing.

### Article 8:

Upon dissolution the board shall, after paying all liabilities of the organization, distribute any remaining assets to such organization or organizations formed and operated exclusively for religious purposes as shall at the time qualify as an exempt organization uner section 501 (c)(3) of the Internal Revenue Service Code 1986 (or corresponding provision of any future U.S. IRS code) as the board shall determine.
