KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, a natural person of full age, citizen of the United States of America and resident of the State of Idaho, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

I.

The name of the corporation shall be BEE HIVE HOMES, INC.

II.

The term for which said corporation shall exist shall be in perpetuity.

III.

The objects and purposes for which this corporation is organized shall be the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The capital stock of this Corporation shall consist of Fifty Thousand (50,000) shares of nonassessable, common stock with \$1.00 par value.

V.



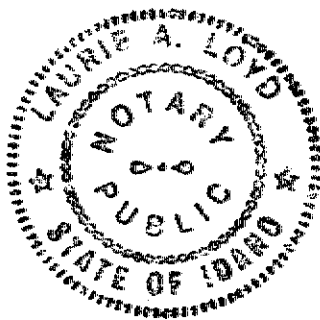
