

ARTICLES OF INCORPORATION

OF THE

-LAST CHANCE CANAL COMPANY-

Know All Men by These Presents, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

And We Hereby Certify,

First: That the name of said Corporation is THE LAST CHANCE CANAL COMPANY.

Second: That the purposes for which it is formed, are to acquire, manage, use, distribute, and otherwise dispose of water of the waters of the North Fork of Snake River, for Agricultural and Domestic purposes; to construct dams, canals, conduits, ditches, flumes, head-works, and other works for the diversion, control and distribution of said waters; to acquire, hold and dispose of rights of way, and other real property needed for such purposes; and to do any and all acts incident to these or any of these ends.

Third: That the Capital Stock shall be ten thousand (\$10,000) dollar divided into 400 shares of twenty five dollars each.

Fourth: That the place where its principal business is to be transacted shall be St. Anthony, Fremont County, Idaho.

Fifth: That the term for which it is to exist is 50 years from and after the date of its Incorporation.
