ARTICLES OF INCORPORATION
OF
IDAHO SERVICE COMPANY.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are bona fide residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho.

And we hereby certify in writing:

-I- That the name of said corporation shall be "IDAHO SERVICE COMPANY."

-II- That the purposes for which said corporation is formed are:

To purchase, hold, sell, improve, maintain, operate and lease real estate and water rights and other real and personal property of every kind and description, and to mortgage and encumber the same, and to erect, manage, care for and maintain, extend and alter buildings and other structures on said real estate.

To engage in farming, livestock raising, mercantile, manufacturing and mining pursuits.

To act as agent, ^{or} broker or attorney-in-fact for any persons or corporations in the buying, selling, dealing in, owning, holding, leasing and managing of real estate and water rights and other real and personal property of every kind and description.

To act as agent or broker in the business of fire, life, accident and fidelity insurance in the business of giving protection to principals and employers and any other kind or class of insurance in all its branches.

To acquire, purchase, sell, own, hold, hypothecate, mortgage, pledge or otherwise deal in notes, mortgages, stocks, bonds, debentures, securities, obligations and all other evidences of indebtedness; to guarantee the payment of principal and interest of mortgages and other securities, and in general to make any contract of guaranty.

To loan money upon personal or other security, either for its own account or as the agent of others, to borrow money and to do any and all other acts and things, and to exercise any and all other powers which a natural person could do and exercise, and which now or hereafter may be authorized by law.

-III- That the principal place of business of said corporation shall be Jerome, County of Lincoln, State of Idaho.

-IV- That the term for which said corporation shall exist shall be fifty (50) years.

-V- That the number of directors of said corporation shall be five (5) and the following named are designated as directors for the first year, and to hold office until their successors are duly elected and qualified:

H. W. Hurlebaus
E. E. Shawver
I. E. Bennett.

-VI- That the amount of the capital stock of said corporation shall be One Hundred Thousand (\$100,000.00) Dollars, divided into One Thousand (1000) shares of the par value of One Hundred (\$100.00) Dollars each, of which six hundred (600) shares are to be common stock and four hundred (400) shares preferred stock.

-VII- That the amount of capital stock of said corporation which has been actually subscribed is Five Hundred (\$500.00) Dollars, common stock, and the following are the names of the subscribers with the number and par value of shares subscribed for by each:
