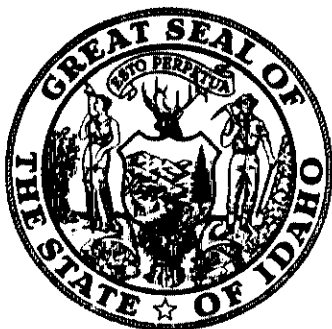
CERTIFICATE OF WITHDRAWAL OF

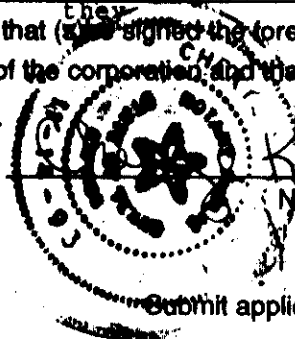
1. The name of the corporation is CONTEL OF THE WEST, INC.
