### ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under and by virtue of the laws of the State of Idaho.

#### WE HEREBY CERTIFY:

FIRST: That the name of this corporation is BONNAKART,
INCORPORATED.

SECOND: That the objects and purposes for which this corporation is organized is as follows:

- 1. To build, erect, construct, lease, purchase or otherwise acquire, manage, maintain and operate a kart or small car track and concession as a public amusement, and other amusements of all kinds for the accommodation and amusement of the public and of individuals; to purchase or otherwise acquire, own, sell, assign, or otherwise transfer and convey, trade, deal in and with goods, wares, merchandise and property of every class, variety and description which may be commensurate with the operation of such amusements, including the operation of refreshment stands, or to otherwise sell food, confections, and non-alcoholic beverages.
- 2. To hold, purchase, or otherwise acquire, to sell, assign, transfer, mortgage, pledge, or otherwise dispose of, shares of the capital stock, bonds, or other evidence of indebtedness created by any other corporation or corporations.
- 3. To make, enter into and execute contracts of every kind and character with individuals, firms, associations and corporations, private, public and municipal, and bodies politic, and with the Government of the United States, and of any state or district thereof.

4. This corporation shall have power to borrow or raise money without limit as to amount by the issue of or upon warrants, bonds, debentures, and other negotiable or transferable instruments, or other obligations of the corporation, and to secure the payment of any such obligation by mortgage, pledge, deed, indenture, agreement or other instrument of trust, or by other lien upon, assignment of, or agreement in regard to all or any part of the property of the corporation wherever situated, whether now owned or hereafter acquired.

5. To do each and every thing necessary, suitable or proper for the accomplishment of any of the purposes, or the attainment of any one or more of the objects herein enumerated, or which shall at any time appear conducive to or expedient for the protection or benefit of this corporation.

THIRD: That the term for which this corporation is to exist is perpetual.

FOURTH: That the location and post office address of the registered office of this corporation shall be 520 Legion Drive, Idaho Falls, Idaho.

<u>FIFTH</u>: That the amount of Capital Stock of this corporation shall be Ten Thousand Dollars (\$10,000.00), to consist of One Thousand (1,000) shares of common stock of the par value of Ten Dollars (\$10.00) each.
