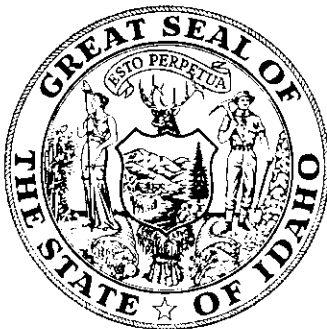
### CERTIFICATE OF AMENDMENT OF

**ARTICLES OF AMENDMENT**

**BOISE CITY BOWLING ASSOCIATION, INC.**

Pursuant to Section 30-327, *Idaho Code*, the Boise City Bowling Association, Inc. ("Association"), hereby adopts these Articles of Amendment to change the name of the Association as set forth in Article I of the Articles of Incorporation of the Association filed with the Secretary of State of the State of Idaho on June 4, 1964, from Boise City Bowling Association, Inc., to Greater Boise Men's Bowling Association, Inc. These Articles of Amendment will effect a name change only and do not alter any provision of the Articles of Incorporation of the Association.

A resolution setting forth the proposed name change and directing that said resolution be submitted to a vote of the voting members was duly adopted by a quorum of the Board of Directors of the Association at a regular meeting held December 9, 1990. Thereupon, written notice of the proposed name change of the Association was duly submitted to the members of the Association and a resolution adopted by a majority of the voting members of the Association at an annual meeting held April 21, 1991. A copy of said resolution as adopted by the voting members of the Association is attached hereto as Exhibit A.



## EXHIBIT A

### Resolution Adopted April 21, 1991:

RESOLVED, That the Board of Directors of the Boise City Bowling Association, Inc., is hereby authorized and directed to adopt a new name for the association, to be known as the Greater Boise Men's Bowling Association, Inc. ("Association"), which name change better reflects the derivation of the membership of the Association and the areas in which the Association participates; and be it

FURTHER RESOLVED, That in conjunction with the above name change and the reasons therefor, Articles I and IV of the Bylaws of the Association are hereby amended to read as follows:

#### ARTICLE I

This organization is formed for the purpose of uniting in a central organization all members of qualified bowling teams, leagues and unattached individuals in the State of Idaho bowling in certified establishments located within the boundaries of Ada County.

#### ARTICLE IV

The name of the Corporation is **GREATER BOISE MEN'S BOWLING ASSOCIATION, INC.**, and the Corporation is incorporated under the laws of the State of Idaho with its principal place of business and registered office and post office address to be fixed by the Board of Directors from time to time.
