

Investment Services, Inc., a corporation of the State of Idaho, whose registered office is located at 200 Main, Lewiston, Idaho, certifies pursuant to the provisions of Section Two, Paragraph 3 of Act No. II of the Acts of 1960, as amended, that at a meeting of the stockholders of said corporation called for the purpose of amending the articles of incorporation, and held on September 1, 1992, it was resolved by the vote of the holders of a two thirds appropriate majority of the shares of each class entitled to vote that ARTICLE II, Paragraph 3 of the Articles of Incorporation is amended to read as follows:
