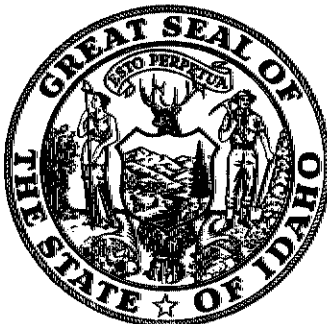

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is DSM DESIGNS, LTD.

ARTICLE II

The period of its duration is perpetual.

ARTICLE III

The purpose or purposes for which the corporation is organized are:

To design, purchase, acquire, hold, sell, exchange, or otherwise deal with jewelry, and to transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
