WE, THE UNDERSIGNED COMMITTEE, DO HEREBY CERTIFY AS FOLLOWS: A NOTICE OF THE MEETING TO INCORPORATE, WAS DULY GIVEN AND SUCH MEETING WAS HELD IN ACCORDANCE THEREWITH ON THE 28TH DAY OF MAY 1959, AT 7:30 6 CLOCK P.M. ON THE SAID DAY.

PAUL R. COCHRAN WAS THE PRESIDING OFFICER OF SUCH MEETING. AT SUCH MEETING, IT WAS DETERMINED TO INCORPORATE SUCH CONGREGATION IN PURSUANCE OF THE LAWS OF THE STATE OF IDAHO.
