OF THE

WE, THE UNDERSIGNED COMMITTEE, DO HEREBY CERTIFY AS FOLLOWS: A NOTICE OF THE MEETING TO INCORPORATE, WAS DULY GIVEN AND SUCH MEETING WAS HELD IN ACCORDANCE THEREWITH ON THE 28TH DAY OF MAY 1959, AT 7:30 O'CLOCK P.M. ON THE SAID DAY.

PAUL R. COCHRAN WAS THE PRESIDING OFFICER OF SUCH MEETING. AT SUCH MEETING, IT WAS DETERMINED TO INCORPORATE SUCH CONGREGATION IN PURSUANCE TO THE LAWS OF THE STATE OF IDAHO.

ARTICLE NO. 1 - NAME

THE NAME OF THE PROPOSED CORPORATION AS DECIDED ON AT SUCH MEETING IS, THE FERNWOOD COMMUNITY BIBLE CHURCH INC.

ARTICLE NO. 2 - LOCATION

THE PRINCIPAL PLACE OF WORSHIP OF SUCH CONGREGATION IS TO BE LOCATED IN FERNWOOD, COUNTY OF BENEWAH, STATE OF IDAHO.

ARTICLE NO. 3 - DURATION

THE TERM OF THE INCORPORATION SHALL BE PERPETUAL.

ARTICLE NO. 4 - PURPOSE

AND WE CERTIFY, THAT THE OBJECTS FOR WHICH THIS CORPORATION IS FORMED ARE: TO ESTABLISH A CHURCH ORGANIZATION IN FERNWOOD, BENEWAH COUNTY, IDAHO, AND IN CONNECTION THEREWITH SUITABLE AND CUSTOMARY ORGANIZATION, FOR ALL PURPOSES TO ADVANCE THE KINGDOM OF GOD AMONG MEN. IT'S DOCTRINES AND CUSTOMS AND PRACTICES ARE EXPECTED TO HARMONIZE WITH THE STANDARD OF GOD'S WORD. TO ESTABLISH AND MAINTAIN A PLACE OF WORSHIP AND TO BUILD, BUY, SELL, OWN OR OTHERWISE HOLD AND DISPOSE OF REAL AND PERSONAL PROPERTY NECESSARY TO PROPERLY ESTABLISH, AND MAINTAIN A PLACE OF WORSHIP.

ARTICLE NO. 5 - MINISTER

THE SAID CHURCH PULPIT SHALL ALWAYS BE SUPPLIED BY A MINISTER SERVING UNDER THE AUSPICES OF VILLAGE MISSIONS INC., 10121 GRANDVIEW ROAD, KANSAS CITY 34, MISSOURI, AS LONG AS THE MINISTER AND VILLAGE MISSIONS AGREES WITH THE DOCTRINES SET FORTH IN THE CONSTITUTION.

ARTICLE NO. 6 - TRUSTEES

THE NUMBER OF TRUSTEES DECIDED ON AT SUCH MEETING WAS THREE (3). THE NAME OF THE TRUSTEES ELECTED AT SUCH MEETING TO HOLD OFFICE UNTIL THE FIRST ANNUAL ELECTION ARE RESPECTIVELY AS FOLLOWS:
