ARTICLES OF INCORPORATION.

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all of whom are citizens and residents of the State of Idaho, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we hereby certify:

(1) That the name of said corporation shall be Thomas Mercantile Company, Limited.

(2) That the purpose for which it is formed is to conduct a general mercantile business.

(3) That the place where the principal business of said corporation shall be transacted is Blackfoot, Bingham County, Idaho.

(4) That the term for which said corporation is to exist is fifty (50) years from and after the date of its incorporation.

(5) That the number of directors of said corporation shall be seven (7), and that the names and residences of the directors who are appointed for the first year and to serve until the election and qualification of their successors, are as follows to wit:

(6) That the amount of the capital stock of the said corporation is twenty-five thousand (\$25000) dollars, and the number of shares into which it is divided is twenty-five hundred (2500), of the par value of ten (\$10) dollars each.
