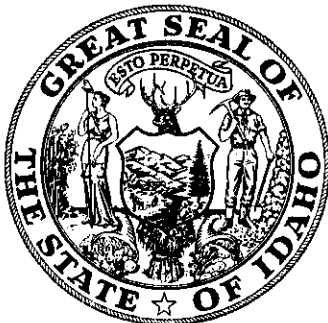
CERTIFICATE OF AMENDMENT OF

ARTICLES OF AMENDMENT
OF THE ARTICLES OF INCORPORATION
OF SCHWEITZER ALPINE RACING SCHOOL, INC.

The name of the corporation is Schweitzer Alpine Racing School, Inc.

The following amendments to the Articles of Incorporation were adopted by unanimous vote of the members of Schweitzer Alpine Racing School, Inc., at its annual meeting on December 27, 1992, at which a quorum was present.

Article IV shall be amended to state as follows:

The purposes of this corporation shall be as follows:

1. To promote involvement of children in alpine ski events.
2. To provide educational and instructional services in alpine skiing to the general population of the North Idaho and Eastern Washington area.

Paragraph 3 of Article IV shall be deleted in its entirety.

Article VIII shall be amended to state as follows:

The general officers of the corporation shall consist of a president, vice-president, secretary and treasurer to be selected by the Board of Directors. The number of directors may be increased or decreased from time to time by amendment of the Bylaws. The directors shall be elected or appointed in the manner and for the terms provided in the Bylaws.


Article IX shall be amended to state as follows:

The Board of Directors shall manage the affairs of the corporation. It shall consist of not less than six or more than twelve directors who shall each serve for a term of three

years. There shall be three classes of directors. Each class shall be as nearly equal in number as possible. The term of the office of the directors of the first class shall expire one year after the first annual meeting of members in December of 1992. The second class shall expire at the second annual meeting after such meeting. The third class shall expire at the end of the third annual meeting after such election. At each annual meeting after such classification, the number of directors equal to the number of the class whose term expires at the time of such meeting shall be elected to hold office until the third succeeding annual meeting.


