

ARTICLES OF INCORPORATION  
of  
**THE TROY LUMBER AND MANUFACTURING COMPANY.**

KNOW ALL MEN BY THESE PRESENTS that we the undersigned, a majority of whom are bonafied residents and freeholders of the State of Idaho, do by these presents voluntarily associate ourselves together as a private corporation under the laws of the State of Idaho.

The name of the corporation shall be The Troy Lumber and Manufacturing Company.

This corporation is formed for the purpose of owning, and operating saw mills, and to sell and manufacture the lumber therefrom. To buy and sell lumber, timber and real estate. To own and operate an electric light plant, and to transact all such business as may be necessary for the successful management of the above.

The place where the principal business is to be transected shall be at the city of Troy, in the County of Latah, State of Idaho.

This corporation shall exist for a period of fifty years.

The number of its directors shall be five, and the names and place of residence of the directors, who are appointed and shall serve for the first year, are as follows:


