#### CERTIFICATE OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are of full age and citizens of the United States, have this day associated ourselves together for the purpose of forming a corporation under and pursuant to Chapter 1, Title 30 of the Idaho Code and we do hereby certify:

#### ARTICLE I

The name of the corporation shall be TRUSSELL'S TREEHOUSE INC.

#### ARTICLE II

Subject to dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

## ARTICLE III

The nature of the business and, the objects and purposes proposed to be transacted, promoted and carried on, are to do any and all the things herein mentioned, as fully and to the same extent as natural persons might or could do, and in any part of the world, viz:

> "The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the Articles of Incorporation of Idaho".

## ARTICLE IV

The amount of the total authorized capital stock of this corporation is Five thousand (5000) shares of No Par  $_{\infty}$ Value.

### ARTICLE V

The principle place of business, registered office and the post office address of the registered office of said corporation shall be Route #5 Box 348, Idaho Falls, county of Jefferson, state of Idaho. Registered Agent Fredrick G. Truscell. Off North County hime Road, no other means besides how no. to list.

ARTICLE VI

The names and mailing addresses of the incorporators is as follows:

ARTICLE VII

The powers of the incorporator are to terminate upon filing of the certificate of incorporation, and the names and mailing ad dresses of the persons who are to serve as directors until the first annual meeting of stockholders or until their successors are elected and qualify are as follows:

ARTICLE VIII

The Directors shall have power to make and alter or amend the By-laws; to fix the amount to be reserved as working capital, and to authorize and cause to be executed, mortgages and liens without limit as to the amount, upon the property and franchise of the Corporation.

The By-laws shall determine whether and to what extent the account and the books of this corporation, or any of them shall be open to the inspection of the stockholders; and no stockholder shall have any right of inspecting any account, or book or document of this Corporation, Except as conferred by the law or By+laws, or by resolution of the stockholders.

With consent in writing, and pursuant to a vote of the holders of a majority of the capital stock issued and outstanding, the Directors shall have authority to dispose, in any manner, of the whole property of this corporation.

The stockholders and directors shall have power to hold their meetings and keep the books, documents and papers of the Corporation outside of the State of Idaho, at such places as may be from time to time designated by the By-laws or by resolution of the stockholders or directors, except as otherwise required by the laws of Idaho.

It is the intention that the objects, purposes and owers specified in the Third paragraph hereof shall, except where otherwise specified in said paragraph, be nowise limited or restricited by reference to or inference from the terms of any other clause or paragraph in this certificate of incorporation, but that the objects, purposes and powers specified in the Third paragraph and in each of the clauses or paragraphs of this charter sahll be regarded as independent objects, purposes and powers.

WE, THE UNDERSIGNED, for the purpose of forming a Corporation under the laws of the State of Idaho, do make, file and record this Certificate and do certify that the facts herein are true; and we have accordingly hereto set our hands.
