ARTICLE OF AMENDMENT

OF

ARTICLES OF INCORPORATION

OF

HONSTEAD MOTOR CO., INC.

meeting held on the 15th day of June, 1971, pursuant to written waiver and consent of all of the stockholders of the corporation, the following resolution was unanimously adopted by vote of approval of all of the stockholders of the corporation as follows, to-wit:

"BE IT RESOLVED, that the Articles of Incorporation of Honstead Motor Co., Inc. and Article V thereof be and the same hereby are amended and modified as follows, to-wit:

The first paragraph of Article V of the Articles of Incorporation shall be amended and modified to read as follows:

'ARTICLE V

The object of this corporation and purposes of this corporation shall be to carry on the business of buying, selling, renting, storing, repairing and caring for automobiles, motorcycles and motor vehicles of allkinds and dealing in supplies therefor and appurtenances thereto; to purchase land, build, purchase or otherwise acquire and operate building, storage houses and garages for the storing, caring for and keeping for hire therein of automobiles, motorcycles and motor vehicles of every kind, nature and description; to buy, sell, trade and deal in all goods, wares and merchandise necessary or incidental to the operation, repair or equipment of automobiles, motorcycles or motor vehicles of any kind, nature, manufacture or description; to engage in the business of financing, insuring and refinancing of automobiles or motor vehicles; to rent real property; and to engage in the business of General Lines Insurance, as defined in Idaho Code, Section 41-903.'

The remaining paragraphs of Article V of the Articles of Incorporation shall remain the same and not be amended or modified."
