

ARTICLES OF INCORPORATION
of
PONY CREEK CANAL COMPANY.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming and organizing a corporation, under the laws of the State of Idaho, and we hereby certify:

I

That the name of said corporation shall be
PONY CREEK CANAL COMPANY.

II

That the purpose for which said Corporation is formed are: To purchase, hold, operate and conduct and maintain, for the uses and benefit of its stockholders, only, an irrigation canal and irrigation system, with all necessary works of diversion and distribution, for the application to irrigation and other beneficial uses of the waters of Pony Creek, in Teton and Madison Counties, in the State of Idaho; and to purchase and hold all necessary rights of way and such other real estate and personal property as may be necessary for the successful conduct of the enterprise. The following is a general description of the course of the canal of said corporation, to wit: Beginning at the point of diversion, on Pony Creek, near the center of the South-east Quarter of the South-east Quarter (SE $\frac{1}{4}$ -SE $\frac{1}{4}$) of Section Thirty-three (33), Township Six North (6 N)

of Range Forty-three (43), East of Boise Meridian, in Teton County, Idaho, and running thence in an irregular course, in a general North-westerly direction across said Section 33, also crossing the North-east portion of Section 32, and the South-west corner of Section 29, and part way across Section 30 in the aforesaid Township and Range in Madison County, Idaho.

III

That said corporation shall be cooperative and non-profit-sharing and non-profit-earning, and its said irrigation system shall be conducted, maintained and operated for the irrigation of the lands of its stockholders, and the supplying of water for their domestic use.

IV

The place where the principal business of said corporation is to be, and shall be transacted, is Rexburg, in Madison County, State of Idaho.

V

That the term for which said corporation shall exist shall be Fifty (50) years, unless sooner dissolved or disincorporated.

VI

That said Corporation shall have a Board of Directors, and the number of its directors shall be three (3), and those appointed for the first year, and their post office addresses are the following:

J. A. Browning,	Canyon Creek, Idaho.

VII

That said Corporation shall have a capital

stock, and the amount of its said capital stock shall be Five Thousand (\$5000.00) Dollars, divided into five hundred (500) shares of the par value of Ten (\$10.00) Dollars each.

That the amount of the capital stock of said Corporation actually subscribed, and the names of the persons subscribing same, and the amounts subscribed by each are as follows:
