**ARTICLES OF INCORPORATION  
OF  
MACKAY BUSINESS ASSOCIATION, INC.**

The undersigned incorporators, desiring to form a non-profit corporation pursuant to the provisions of the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation:

**ARTICLE ONE:** The name of the Corporation is Mackay Business Association, Inc.

**ARTICLE TWO:** The purpose of the Corporation is to increase the economic stability of Mackay and help the city prosper by providing assistance and support to new and existing businesses.

**ARTICLE THREE:** The period of duration of the Corporation is perpetual.

**ARTICLE FOUR:** The number of Directors constituting the initial Board of Directors is four, and the names and addresses of the persons who are to serve as Directors until the first annual meeting of the Corporation, or until their successors are elected and qualify, are as follows:

50% to the City of Mackay


