ARTICLES OF INCORPORATION OF ISLAND HIGH LINE DITCH COMPANY

- 1. The name of the corporation is ISLAND HIGH LINE DITCH COMPANY.
- 2. This corporation is a non-profit corporation.
- The period of its duration is perpetual.
- 4. Its purpose is to transact the business of acquiring, owning, holding, maintaining, repairing and operating certain irrigation diversion works and canals and all other acts necessary and proper for delivery of irrigation water to shareholders and all other business not forbidden by law.
- 5. It shall have authority to issue Ten Thousand (10,000) shares, all of one class, NO par value.
- 6. No person shall become a member of this corporation without owning at least one (1) share of stock, also known as membership certificate. Said share shall represent irrigation rights to respective real property served by this corporation and said share and irrigation rights shall not be severed from the land so irrigated except for forfeiture for failure to pay assessments.
