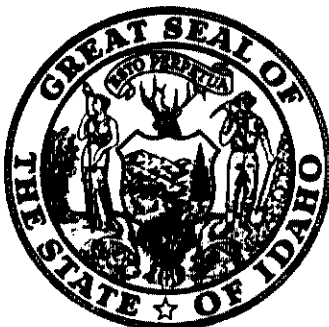

ARTICLES OF INCORPORATION

THE UNDERSIGNED, acting as incorporator of a corporation under the Idaho Professional Services Corporation Act, adopts the following Articles of Incorporation for such corporation.

FIRST

The name of the corporation is Dirk T. Carlson, M.D., P.A.

SECOND

The period of its duration is perpetual.

THIRD

The purpose for which the corporation is organized is for the conduct of the profession of practicing medicine and for the transaction of any or all lawful business for which the corporation may be incorporated under the Idaho Professional Services Corporation Act.

FOURTH

The aggregate number of shares which the corporation shall have the authority to issue is 100,000 shares of common stock with no par value per share.

FIFTH

Shareholders shall have a preemptive right to acquire unissued or treasury shares or securities convertible into such shares or carrying a right to subscribe to or acquire shares, except as provided in the Idaho Professional Services Corporation Act.
