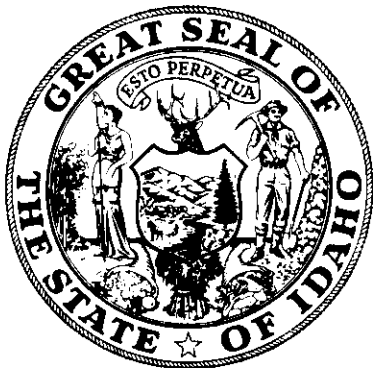

ARTICLES OF AMENDMENT
OF
AHERIN, RICE & BROWN, P.A.

PURSUANT TO Idaho Code section 30-1-59, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

The following amendment to the Articles of Incorporation was adopted by Resolution upon the written consent of the holders of all of the stock of the corporation, in the manner prescribed by Idaho Code section 30-1-145, on September 1, 1987:

"RESOLVED, that Articles ONE and FIVE of the Articles of Incorporation of AHERIN, RICE & BROWN, P.A., be and the same are hereby amended to read as follows:

Article ONE. The name of the corporation shall be AHERIN & RICE, P.A.


Article FIVE. The number of Directors of the corporation shall be at least two (2) but said number may be increased to five (5) or more at any time in the future as may be prescribed by the Bylaws of this corporation; every director must be the owner in his own right of at least one share of the capital stock of this corporation.
