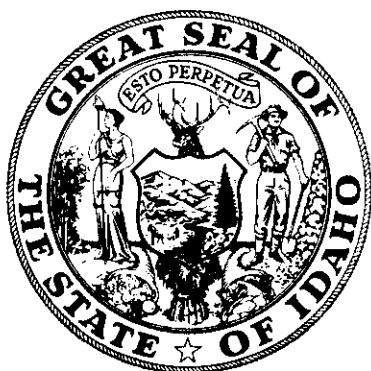

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation: STATE

FIRST: The name of the corporation is Psychological Assessment Center, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are to conduct computerized psychological testing and the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 5,000 (five thousand) without par value.

FIFTH: The address of the initial registered office of the corporation is 6140 Emerald Street, Boise, Idaho 83704 and the name of its initial registered agent at such address is Beverly Hurst.




