ARTICLES OF INCORPORATION
OF

We, the undersigned, being adult citizens of the ~~United~~ ^{RECEIVED} States of America, do hereby form a corporation pursuant to Chapter 1 of Title 30, Idaho Code, and do hereby adopt and certify the following Articles of Incorporation, to-wit:

ARTICLE I

The name of the Corporation shall be Killgore Excavating Inc.

ARTICLE II

The term of existence of this corporation shall be perpetual.

ARTICLE III

The purposes for which this corporation is organized are for the transactions of any and all lawful business for which corporations may be incorporated under this act.

ARTICLE IV

The aggregate number of shares which the corporation shall have the authority to issue is One Hundred Thousand (100,000); the shares shall consist of one (1) class only; the par value of each share shall be the sum of ten dollars (\$10.00); the total authorized capital stock of the corporation is the sum of One Million Dollars even (\$1,000,000) The stock of this corporation shall be nonassessible.
