

The incorporators, J. Brad Hamilton and Karen Hamilton, natural persons, citizens of the United States of America, and of the United Kingdom, respectively, and residents of the State of Idaho, hereby adopt the following articles of incorporation:

ARTICLE ONE. NAME. The name of the corporation is Hamilton Water Systems, Inc.

ARTICLE TWO. DURATION. The period of duration of the corporation is perpetual.

ARTICLE THREE. PURPOSES. The corporation is organized for the conduct of a softwater service and sales business, and for any incident, allied, or other lawful purpose.

ARTICLE FOUR. STOCK. The corporation is authorized to issue a total number of 20,000 shares of stock, each share having a par value of \$10.00. Such shares shall be of a single class.

ARTICLE FIVE. REGISTERED OFFICE AND AGENT. The address of the corporation's initial registered office in the State of Idaho is 210 North Fourth Avenue, Pocatello, Bannock County, Idaho 83204, and its initial registered agent at that address is J. Brad Hamilton.

ARTICLE SIX. DIRECTORS. The incorporators shall constitute the initial board of directors, who are to serve as directors until the first annual meeting of the shareholders or until their successors are elected and qualified.
