BE IT REMEMBERED, That at a regular meeting of the members of the First Church of Christ, Scientist, of Payette, Idaho, held, pursuant to the By-Laws of said corporation, which corporation is duly organized and existing under the laws of the State of Idaho, at its place of business at Payette, Idaho, on the 8th day of March, 1957, after due and proper notice has been given the members thereof by publication of the notice of said meeting setting forth the fact that the meeting was to consider the amendment of the Articles of Incorporation, and at which meeting there was a quorum of the members of said corporation present in accordance with its Articles of Incorporation and the laws of the State, the following resolution was adopted by a majority vote in favor of the amendment as follows: Total number of members ^{present} 12 ; total number of members voting for amendment 12 .

14 RESOLVED, That the corporate seal of the First Church of Christ, Scien-
15 tist, of Payette, Idaho, which will expire on the 23rd day of April,
16 1957, is hereby extended to be in perpetual existence, continuing
 from this time forth in perpetuity unless sooner dissolved by the
 voluntary action of the members;

17 FURTHER RESOLVED, That the renewing amendment and substituting Articles
18 of Incorporation submitted to the members at the meeting and hereto
attached, be, and the same are hereby adopted as the Articles of In-
corporation of the corporation under the renewal provision;

20 FURTHER RESOLVED, That the President and Clerk of this corporation, be,
21 and they are hereby authorized and directed to sign, acknowledge,
22 record, publish and do any/all things which are by law required to
execute, complete and carry into effect the above resolutions, and
to execute, sign and acknowledge the renewed amendment and substi-
tuting Articles of Incorporation duly adopted at said meeting.

9 KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned have this day
10 voluntarily associated ourselves together for the purpose of forming a corporation
11 under the laws of the State of Idaho, and we hereby certify:

1.

13 The name of This Corporation is 'FIRST CHURCH OF CHRIST SCIENTIST, OF
14 PAYETTE, IDAHO'.

II.

16 The purpose for which said corporation is formed is the carrying on and
17 conducting public worship and the benevolent purposes connected therewith, accord-
18 ing to the tenets of the religious denomination known as 'Christian Scientist';
19 also to acquire and hold and use such real estate and other property as may be
20 reasonably necessary for the purpose of carrying into effect the objects herein-
21 before mentioned.

23 The place where the principal business of this corporation is to be
24 transacted, is Payette, Canyon County, Idaho.

26 The term for which it is to exist is in perpetuity from and after date
